Under the terms of the agreement with the City of Houston, Master Plan and all future capital improvement projects will transfer to the City at end of the project. On December 10, 2020, the Arboretum transferred ownership of completed Master Plan assets to the City of Houston with a total net book value of \$4,202,406, which included renovation of the 11,000 square foot Nature Center. Accordingly, a loss on retirement of property and equipment has been recorded in the statements of activities for the year ended June 30, 2021.
